#### For the U.S.A. and Canada

Units shipped to the U.S.A. and Canada are designed for operation on 120 volts AC only


The wires in this mains lead are coloured in accordance with the following code:

Blue ...... Neutral Brown ..... Live

The wires in this mains lead must be connected to the terminals in the plug as follows:

#### Wire colour

Plug terminal marking Blue ...... N or Black Brown ..... L or Red



#### Notes:

- 1. If a 13-amp plug is used, this must be fitted with a 5-amp
- 2. If a 3-pin plug with earthing contact is used, no wire must be connected to the E terminal.


Units shipped to countries other than the above countries are equipped with an AC voltage selector switch under the turntable platter. Refer to the following paragraph for the proper setting of this switch.

#### AC voltage selection

This unit operates on 110-120 or 220-240 volts AC. The AC voltage selector switch under the turntable platter is set to the voltage that prevails in the area to which the unit is shipped. Before connecting the power cord to your AC outlet, make sure that the setting position of this switch matches your line voltage. If not, it must be set to your voltage in accordance with the following direction.

- Power sources The unit should be connected to a power supply only of the type described in the operating instructions or as marked on the appliance.
- 2. Power-cord protection Power-supply cords should be routed so that they are not likely to be walked on or pinched by items placed upon or against them, pay particular attention to cords at plugs, convenience receptacles, and the point where they exit from the unit.

Never pull or stretch



- Grounding or polarization The precautions should be taken so that the grounding or polarization means of this unit is not defeated.
- **4. Ventilation** The unit should be situated so that its location or position does not interfere with its proper ventilation.

To maintain good ventilation, do not put records or a table-cloth on the unit. Place the unit at least 10 cm away from the walls.

Do not use the unit on a bed, sofa, rug or similar surface that may block the ventilation openings.



5. Water and moisture — The unit should not be used near water — for example, near a bathtub, washbowl, kitchen sink, laundry tub, in a wet basement, or near a swimming pool, etc.



6. Temperature — The unit may not function properly if used at extremely low, or freezing temperatures. The ideal ambient temperature is above +5°C (41°F).

7. Heat — The unit should be situated away from heat sources such as radiators, heat registers, stoves, or other units (including amplifiers) that produce heat.




8. Electric shock — Care should be taken so that objects do not fall and liquid is not spilled into the enclosure through openings. If a metal object, such as a hair pin or a needle, comes into contact with the inside of this unit, a dangerous electric shock may result.  Enclosure removal — Never remove the enclosure. If the internal parts are touched accidentally, a serious electric shock might occur.


- 13. Nonuse periods The power cord of the unit should be unplugged from the outlet when left unused for a long period of time.

- **15. Damage requiring service** The unit should be serviced by qualified service personnel when:
  - **A.** The power-supply cord or the plug has been damaged; or
  - **B.** Objects have fallen, or liquid has been spilled into the unit; or
  - C. The unit has been exposed to rain; or
  - **D.** The unit does not appear to operate normally or exhibits a marked change in performance; or
  - E. The unit has been dropped, or the enclosure damaged.
- 16. Servicing The user should not attempt to service the unit beyond that described in the operating instructions. All other servicing should be referred to qualified service personnel.
- 17. Outdoor antenna grounding If an outside antenna is connected to the receiver, be sure the antenna system is grounded so as to provide some protection against voltage surges and built up static charges. Section 810 of the National Electrical Code, ANSI/ NFPA No. 70—1984, provides information with respect to proper grounding of the mast and supporting structure, grounding of the lead-in wire to an antenna discharge unit, size of grounding con-

ductors, location of antenna-discharge unit, connection to grounding electrodes, and requirements for the grounding electrode. See Figure.




**18. Power lines** — An outdoor antenna should be located away from power lines.


- 1. Item 3 is not required except for grounded or polarized equipment.





### In case of difficulty

What appears to be a malfunction may not always be serious. If your unit should not perform as expected, consult the table below to see if the problem can be corrected before seeking help from your dealer or service representative.

Symptom	Cause	Remedy
No sound from both left and right chan- nels or from one channel.	Turntable output cables disconnected. The function switch of the amplifier is not set to PHONO MM.	Check connections to amplifier.     Set the function switch to PHONO MM.
Loud hum, no music.	Poor connection of turntable output cables.	Make solid connections to amplifier.
Loud hum with music.	Turntable output cables picking up hum from AC cord.	Separate output cables from AC cord or reverse AC cord plug.
Buzzing noise with music.	Turntable output cable picking up TV signal.	Relocate output cord for minimum pickup.
Howling drowns out music when volume is increased.	Speaker vibration is picked up by turntable.	Separate turntable from speakers.
Turntable platter does not turn.	Poor AC plug contact.	Check connection. Make sure AC outlet is active.
Poor tracking.	Excessive dust on record or stylus.	Remove dust from record or stylus.

Note:

Do not use contact cleaner because it could cause a malfunction. Be specially careful against contact cleaners containing oil, for they may deform the plastic components.
